- The RSUs vest in their entirety on the earlier of a) the anniversary of the date of the grant and b) the date of the Issuer's annual meeting of shareholders in the following year. The date of the grant is May 29, 2026.
- The RSUs vested in a single installment on May 29, 2026; there was no expiration date for the RSUs.
